

## Use of Artificial Intelligence

The purpose of this page is to explain in a transparent manner the use of artificial intelligence (AI) systems on the [network-presidents.eu](https://network-presidents.eu) website, in accordance with the European Regulation on Artificial Intelligence (EU AI Act) and the data protection requirements set out in the General Data Protection Regulation (GDPR).

### 1. Use of artificial intelligence on [network-presidents.eu](https://network-presidents.eu)

The [network-presidents.eu](https://network-presidents.eu) website uses artificial intelligence systems only in the following context:

#### *a) Automatic translation of documents*
